What does the fund invest in?

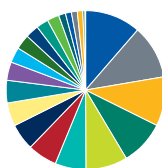
The fund seeks to provide capital growth with modest income potential by investing primarily, directly or indirectly, in a diversified portfolio of other mutual funds with an emphasis on global, U.S. and Canadian equity and balanced funds. The fund will have small exposure to North American fixed income funds and may also invest in ETFs ("exchange-traded funds") or other securities to gain direct exposure to an asset class. The target asset allocation is 25% - 45% in fixed income securities and 55% - 75% in equity securities.

The charts below give you a snapshot of the fund's investments on April 30, 2024. The Investment mix chart shows the fund's proportionate sector allocation of the reference funds' investments and where applicable, the fund's direct investments. The Fund's investments will change.

How risky is it?

The value of the fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

Risk rating

IA Clarington Investments Inc. has rated the volatility of this fund as **low to medium**.

This rating is based on how much the fund's returns have changed from year to year. It doesn't tell you how volatile the fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

Like most mutual funds this fund doesn't have any guarantees. You may not get back the amount of money you invest.

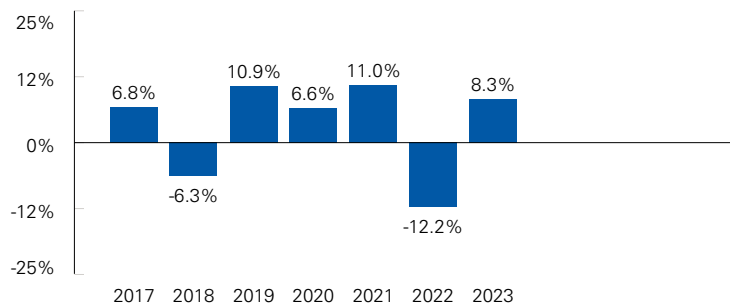
How has the fund performed?

This section tells you how Series T5 units of the fund have performed over the past seven years. Returns are after expenses have been deducted. These expenses reduce the fund's returns. The performance of Series B5, E5 and L5 units would be similar to the performance of Series T5 but would vary as a result of the difference in the combined management and administration fees compared to Series T5 units as disclosed in the fee decrease table under "Fund Expenses" below.

Year-by-year returns

This chart shows how Series T5 units of the fund performed in each of the past seven calendar years. The fund dropped in value in two of the seven years.

The range of returns and change from year to year can help you assess how risky the fund has been in the past. It does not tell you how the fund will perform in the future.



Best and worst 3-month returns

This table shows the best and worst returns for Series T5 units of the fund in a 3-month period over the past seven years. The best and worst 3-month returns could be higher or lower in the future. Consider how much of a loss you could afford to take in a short period of time.

Average return

A person who invested \$1,000 in Series T5 units of the fund since its inception holds today \$1,379, which represents an annual compounded rate of return of 4.09%.

Who is this fund for?

Investors who:

- Seek the possibility of capital appreciation*;
- Have low to medium risk tolerance;
- Plan to invest over the medium to long term.

*Distributions on this series are expected to include a return of capital, which can erode the value of your investment.

A word about tax

In general, you'll have to pay income tax on any money you make on a fund. How much you pay depends on the tax laws where you live and whether or not you hold the fund in a registered plan, such as a Registered Retirement Savings Plan or a Tax-Free Savings Account.

Keep in mind that if you hold your fund in a non-registered account, fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.

How much does it cost?

The following tables show the fees and expenses you could pay to buy, own and sell Series B5, E5, L5 and T5 units of the fund. The fees and expenses, including any commissions, can vary among series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

As part of the Program, we may automatically switch your investment in Series B5, L5 and T5 into Series E5 when your aggregate eligible investment in IA Clarington Funds reaches \$100,000, if at that time, Series E5 has a lower management fee. Upon expiry of the redemption fee schedule, your investment will be switched to another series, under the Front End Option, at the same or lower fee.

If your aggregate eligible investment no longer meets the eligibility threshold, we may switch your investment back into another series, which may have a higher management fee. See the fee decrease table under "Fund Expenses" below.

1. Sales charges

Series B5 and E5 units are only available under the Front End Option. Series L5 and T5 are not available to purchases under the Deferred Sales Charge, Low Load and Advisor Service Charge Options and are only available by switching from securities of another IA Clarington Fund under the same sales charge option. For information about the redemption fees payable when you redeem units purchased under the Deferred Sales Charge, Low Load and Advisor Service Charge Options, please see **Redemption Fees** under the heading "Fees and Expenses" of the Simplified Prospectus and speak to your representative for additional details.

2. Fund expenses

You don't pay these expenses directly. They affect you because they reduce the fund's returns. Series B5, L5 and T5 have higher combined management and administration fees than Series E5.

More about the trailing commission

The trailing commission is an ongoing commission. It is paid for as long as you own the fund. It is for the services and advice that your representative and their firm provide to you. IA Clarington Investments Inc. pays the trailing commission to your representative's firm. It is paid from the fund's management fee and is based on the value of your investment.

Series T5 units are not available under the Front End Option. We no longer pay trailing commissions to discount brokers.

Upon the automatic switch of your investment, your representative may receive a higher trailing commission of up to 1.00% of your investment each year.

3. Other fees

You may have to pay other fees when you buy, hold, sell or switch units of the fund.

Fee	What you pay
Short-term trading fee	We may charge up to 2.00% of the value of units if there is a pattern of excessive redemptions/switches within 90 days of buying them. This fee goes to the fund.
Switch fee	Your representative's firm may charge you up to 2.00% of the value of units you switch.

What if I change my mind?

Under securities law in some provinces and territories, you have the right to:

- withdraw from an agreement to buy mutual fund securities within two business days after you receive a simplified prospectus or Fund Facts document, or
- cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, Fund Facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory. For more information, see the securities law of your province or territory or ask a lawyer.
