### What does the fund invest in?

The fund aims to provide a return that is similar to the return of a Canadian dividend mutual fund by investing primarily in units of a Canadian dividend fund managed by IA Clarington Investments Inc. The fund may also invest in securities similar to those held by a Canadian dividend mutual fund. The fund may invest up to 30% of its assets in foreign securities.

The charts below give you a snapshot of the fund's investments on April 30, 2021. If the fund invested in one or more mutual funds, the Investment mix chart shows the fund's proportionate sector allocation of the reference funds' investments and where applicable, the fund's direct investments. The Fund's investments will change.

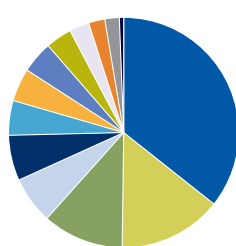

### How risky is it?

The value of the fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

### Risk rating

IA Clarington Investments Inc. has rated the volatility of this fund as **medium**.

This rating is based on how much the fund's returns have changed from year to year. It doesn't tell you how volatile the fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

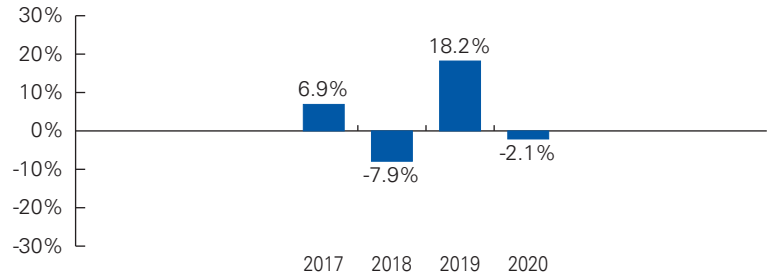
How has the fund performed?

This section tells you how Series A shares of the fund have performed over the past four years. Returns are after expenses have been deducted. These expenses reduce the fund's returns.

Year-by-year returns

This chart shows how Series A shares of the fund performed in each of the past four calendar years. The fund dropped in value in two of the four years.

The range of returns and change from year to year can help you assess how risky the fund has been in the past. It does not tell you how the fund will perform in the future.



Best and worst 3-month returns

This table shows the best and worst returns for Series A shares of the fund in a 3-month period over the past four years. The best and worst 3-month returns could be higher or lower in the future. Consider how much of a loss you could afford to take in a short period of time.

Average return

A person who invested \$1,000 in Series A shares of the fund on June 27, 2016 would have had \$1,414 on April 30, 2021. This works out to an annual compounded return of 7.49%.

Who is this fund for?

Investors who:

- Seek dividend income and the possibility for capital appreciation;
- Have medium risk tolerance;
- Plan to invest over the medium to long term.

A word about tax

In general, you'll have to pay income tax on any money you make on a fund. How much you pay depends on the tax laws where you live and whether or not you hold the fund in a registered plan, such as a Registered Retirement Savings Plan or a Tax-Free Savings Account.

Keep in mind that if you hold your fund in a non-registered account, fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.

How much does it cost?

The following tables show the fees and expenses you could pay to buy, own and sell Series A shares of the fund. The fees and expenses, including any commissions, can vary among series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

1. Sales charges

You have to choose a sales charge option when you buy the fund. Ask about the pros and cons of each option.

The commission is not deducted from your investment. You pay IA Clarington Investments Inc. a redemption fee (calculated as a percentage of the amount invested) if you sell your investment within three years of purchase, or switch your investment to another sales charge option. You can switch to securities of another fund under the Low Load Option without paying any redemption fees at the time of the switch. The low load sales charge schedule will be based on the date you bought the first fund.

2. Fund expenses

You don't pay these expenses directly. They affect you because they reduce the fund's returns.

As at March 31, 2021, the fund's expenses were 2.53% of its value. This equals \$25.30 for every \$1,000 invested.

We may automatically switch your investment in Series A, into elite pricing Series E when your investment reaches \$100,000, if at that time, Series E has a lower management fee.

If your investment no longer meets the eligibility threshold, we may switch your investment back into Series A, which may have a higher management fee. Please see *Switching Between Series* under the heading "Purchases, Switches and Redemptions" of the Simplified Prospectus and speak to your representative for additional details.

More about the trailing commission

The trailing commission is an ongoing commission. It is paid for as long as you own the fund. It is for the services and advice that your representative and their firm provide to you. IA Clarington Investments Inc. pays the trailing commission to your representative's firm. It is paid from the fund's management fee and is based on the value of your investment. The rate depends on the sales charge option you choose.

3. Other fees

You may have to pay other fees when you buy, hold, sell or switch shares of the fund.

Fee	What you pay
<p><b>Short-term trading fee</b></p>	<p>We may charge up to 2.00% of the value of shares if there is a pattern of excessive redemptions/switches within 90 days of buying them. This fee goes to the fund.</p>
<p><b>Switch fee</b></p>	<p>Your representative's firm may charge you up to 2.00% of the value of shares you switch.</p>

**What if I change my mind?**

**Under securities law in some provinces and territories, you have the right to:**

- withdraw from an agreement to buy mutual fund securities within two business days after you receive a simplified prospectus or Fund Facts document, or
- cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, annual information form, Fund Facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory. For more information, see the securities law of your province or territory or ask a lawyer.
