### What does the fund invest in?

The Fund's objective is to provide a consistent stream of income and capital appreciation by investing primarily, directly or indirectly through other mutual funds or exchange traded funds, in fixed income and equity securities from around the world. The Fund may also use derivatives to manage volatility. The Fund may invest up to 100% of its assets in foreign securities.

The charts below give you a snapshot of the fund's investments on January 12, 2022. The fund's investments will change.

#### Top 10 investments (January 12, 2022)

Because the fund is new, its top 10 investments are not available.

#### Investment mix (January 12, 2022)

Because the fund is new, its investment mix is not available.

### How risky is it?

The value of the fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

### Risk rating

IA Clarington Investments Inc. has rated the volatility of this fund as **low**.

Because this is a new fund, the risk rating is only an estimate by IA Clarington Investments Inc. Generally, the rating is based on how much the fund's returns have changed from year to year. It doesn't tell you how volatile the fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

**How has the fund performed?**

**Who is this fund for?**

**Investors who:**

- Seek the possibility for income and potential for capital appreciation;
- Have low risk tolerance;
- Plan to invest over medium to long term.

**A word about tax**

In general, you'll have to pay income tax on any money you make on a fund. How much you pay depends on the tax laws where you live and whether or not you hold the fund in a registered plan, such as a Registered Retirement Savings Plan or a Tax-Free Savings Account.

Keep in mind that if you hold your fund in a non-registered account, fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.

**How much does it cost?**

The following tables show the fees and expenses you could pay to buy, own and sell Series I units of the fund. The fees and expenses, including any commissions, can vary among series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

**1. Sales charges**

This series is sold with no sales charge. Any redemption fees will be set out in the agreement between you and IA Clarington Investments Inc.

**2. Fund expenses**

You don't pay these expenses directly. They affect you because they reduce the fund's returns.

The fund's expenses are made up of operating expenses and trading costs. The series does not pay a management or fixed administration fee. Because this series is new, its operating expenses and trading costs are not yet available.

**More about the trailing commission**

There is no trailing commission paid for Series I units of the fund.

**3. Other fees**

You may have to pay other fees when you buy, hold, sell or switch units of the fund.

Fee	What you pay
<b>Management fees</b>	The series does not pay IA Clarington Investments Inc. a management fee. Any management fees that you are required to pay IA Clarington Investments Inc. will be set out in the agreement between you and IA Clarington Investments Inc. You can negotiate the management fees with IA Clarington Investments Inc. They will not exceed the Series A management fee of the fund, which is currently at an annual rate of 1.75% of the fund's value.
<b>Short-term trading fee</b>	Up to 2.00% of the value of units you sell or switch within 30 days of buying them. This fee goes to the fund.
<b>Switch fee</b>	Your representative's firm may charge you up to 2.00% of the value of units you switch.

**What if I change my mind?**

**Under securities law in some provinces and territories, you have the right to:**

- withdraw from an agreement to buy mutual fund securities within two business days after you receive a simplified prospectus or Fund Facts document, or
- cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, annual information form, Fund Facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory. For more information, see the securities law of your province or territory or ask a lawyer.
