**Minimum investment:** \$100,000 initial; \$500 additional (may, in limited circumstances, be waived)

### What does the fund invest in?

The Fund's objective is to provide long-term capital growth by investing primarily, either directly or indirectly through other mutual funds, in securities of issuers that meet the sub-advisor's socially responsible investment principles. The investment portfolio will have a bias toward foreign and Canadian equity securities with the remainder in fixed income securities. The Fund may invest up to 100% of its assets in foreign securities.

The charts below give you a snapshot of the fund's investments on January 12, 2022. The fund's investments will change.

#### Top 10 investments (January 12, 2022)

Because the fund is new, its top 10 investments are not available.

#### Investment mix (January 12, 2022)

Because the fund is new, its investment mix is not available.

### How risky is it?

The value of the fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

### Risk rating

IA Clarington Investments Inc. has rated the volatility of this fund as **low to medium**.

Because this is a new fund, the risk rating is only an estimate by IA Clarington Investments Inc. Generally, the rating is based on how much the fund's returns have changed from year to year. It doesn't tell you how volatile the fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

**How has the fund performed?**

**Who is this fund for?**

**Investors who:**

- Seek the possibility for capital appreciation\*;
- Have low to medium risk tolerance;
- Plan to invest over medium to long term.

\*Distributions on this series are expected to include a return of capital, which can erode the value of your investment.

**A word about tax**

In general, you'll have to pay income tax on any money you make on a fund. How much you pay depends on the tax laws where you live and whether or not you hold the fund in a registered plan, such as a Registered Retirement Savings Plan or a Tax-Free Savings Account.

Keep in mind that if you hold your fund in a non-registered account, fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.

**How much does it cost?**

The following tables show the fees and expenses you could pay to buy, own and sell Series E6 units of the fund. The fees and expenses, including any commissions, can vary among series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

**1. Sales charges**

Series E6 units are only available under the Front End Option.

Front End Option	0% to 5% of the amount you buy	\$0 to \$50 on every \$1,000 you buy	You and your representative decide on the rate. The initial sales charge is deducted from the amount you buy. It goes to your representative's firm as a commission.

**2. Fund expenses**

You don't pay these expenses directly. They affect you because they reduce the fund's returns.

The fund's expenses are made up of the management fee, fixed administration fee, other operating expenses and trading costs. The series' annual management fee is 1.80% and the annual fixed administration fee is 0.27% of the series' value. Because this series is new, its operating expenses and trading costs are not yet available.

If your investment no longer meets the minimum investment threshold, we may switch your investment into another series, which may have a higher management fee. Please see *Switching Between Series* under the heading "Purchases, Switches and Redemptions" of the Simplified Prospectus and speak to your representative for additional details.

**More about the trailing commission**

The trailing commission is an ongoing commission. It is paid for as long as you own the fund. It is for the services and advice that your representative and their firm provide to you. IA Clarington Investments Inc. pays the trailing commission to your representative's firm. It is paid from the fund's management fee and is based on the value of your investment.

**3. Other fees**

You may have to pay other fees when you buy, hold, sell or switch units of the fund.

Fee	What you pay
<b>Short-term trading fee</b>	Up to 2.00% of the value of units you sell or switch within 30 days of buying them. This fee goes to the fund.
<b>Switch fee</b>	Your representative's firm may charge you up to 2.00% of the value of units you switch.

**What if I change my mind?**

**Under securities law in some provinces and territories, you have the right to:**

- withdraw from an agreement to buy mutual fund securities within two business days after you receive a simplified prospectus or Fund Facts document, or
- cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, annual information form, Fund Facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory. For more information, see the securities law of your province or territory or ask a lawyer.
