## Management Discussion of Fund Performance

The management discussion of fund performance for IA Wealth Balanced Portfolio (the "Fund") represents management's view of the significant factors and developments affecting the Fund's performance and outlook for the 6-month period ended September 30, 2021. IA Clarington Investments Inc. is the manager (the "Manager") of the Fund.

The Fund's Portfolio Manager is Industrial Alliance Investment Management Inc. ("IAIM" or the "Portfolio Manager" or the "fund manager").

Series LX and Series X of the Fund are closed to new investors. Investors who currently hold these series may purchase additional shares.

## Results of Operations

The Fund's Net Assets increased by 36.6% or \$77.5 million during the period, from \$211.6 million on March 31, 2021 to \$289.1 million on September 30, 2021. This change in Net Assets resulted from an increase of \$68.3 million due to fund mergers, an increase of \$3.3 million due to net sales, a decrease of \$0.2 million due to distributions and an increase of \$6.1 million due to investment operations, including market volatility, income and expense.

The average Net Asset Value of the Fund increased by 16.3% or \$33.7 million in comparison to the prior period, from \$206.1 million to \$239.8 million. Average Net Asset Value influence revenue earned and expenses incurred by the Fund during the period.

Series B units of the Fund returned 3.5% for the six-month period ending September 30, 2021. The performance of the other series of the Fund is substantially similar, save for differences in fees and expense structure. Refer to the "Past Performance" section for performance information of each series.

The Fund's broad-based benchmark, the MSCI World Index<sup>A</sup>, returned 8.6% for the same six-month period. The comparison to this broad-based index has been provided to help you understand the Fund's performance relative to the general performance of the global equity market. The Fund's benchmark, which is composed of the FTSE Canada Universe Bond Index (40%), the MSCI World Index<sup>A</sup> (28%), the S&P/TSX Composite Index (15%), the ICE BofA US High Yield Constrained Index (CAD Hedged) (10%), and the S&P 500 Index (7%) returned 5.3% for the same period. This comparison to Fund performance is more useful, because it more closely reflects the asset classes in which the Fund invests. The Fund's return calculation for all series includes fees and expenses, which are not applicable in generating a return for the benchmark.

During the period, the COVID-19 Delta variant spread quickly around the world. Data showed that vaccinations significantly reduce the risk of serious complications and death, but that other measures were still needed to avoid further lockdowns in certain economic sectors. The rise in inflation also made headlines. In Canada, total inflation at the end of the period was above 4% on an annual basis, compared to 5% in the U.S. Recently, the U.S. Federal Reserve Board (the Fed) announced that, if conditions remained favourable, it expects to gradually reduce its quantitative easing program during the fourth quarter until a possible end in the summer of 2022.

The Canadian economy performed well, partly as a result of its strong labour market. In this environment, interest rates have increased slightly leading to some pressure on bond prices. Over the last quarter, the Canadian bond market, as measured by the FTSE Canada Universe Bond Index, returned -0.5%. Over the last six months, the same index returned 1.1%.

U.S. equities, as measured by the S&P 500 Index, gained 9.2% over the period (10.0% in Canadian dollars). Canadian equities, as measured by the S&P/TSX Composite Index, increased 8.7%. Global equities, represented by the MSCI World Index, returned 8.2% for the period (8.6% in Canadian dollars), while international equities, as measured by the MSCI EAFE Index, rose 6.2% (5.5% in Canadian dollars). Emerging markets equities, as measured by the MSCI Emerging Markets Index, declined 2.9% (-2.5% in Canadian dollars).

The Fund generally held overweight allocations to foreign and Canadian equity underlying funds, and an underweight exposure to fixed-income funds, which contributed to performance, given the outperformance of equity markets relative to fixed-income markets. Select exposures to Canadian financials, through the use of exchange-traded funds (ETFs), also contributed to performance. An ETF, or exchange traded fund, is a security that trades openly on a stock exchange and represents an underlying basket of securities (frequently an index).

Top individual contributors to the Fund's performance included IA Wealth Core Bond Pool and IA Clarington Loomis Global Multisector Bond Fund, as both outperformed on a relative basis. Within IA Wealth Core Bond Pool, an underweight exposure to federal bonds contributed to performance, as did security selection in mid- and long-term federal bonds. IA Clarington Loomis Global Multisector Bond Fund outperformed as a result of security selection, particularly within high-yield corporate credit, and exposure to convertible bonds. High-yield corporate credit are fixed-income securities with higher risk and higher yield than investment grade fixed-income securities. Convertible bonds are corporate bonds that can be exchanged for common stock in the issuing company. IA Clarington Canadian Small Cap Fund also contributed to performance as it benefited from a lack of direct gold exposure and an underweight allocation to the healthcare sector.

The fund manager's equity risk-mitigation strategy on U.S. equity indices detracted from performance, as equity markets generated strong positive returns, especially in the second quarter of 2021. The Fund's overweight exposure to emerging market equities also detracted from performance. Top individual detractors included IA Clarington Thematic Innovation Class and IA Clarington Global Equity Fund.

The fund manager tactically adjusted the Fund's composition during the period, and dynamically managed exposure to Canadian and U.S. dollars. The fund manager also increased the Fund's exposure to gold, which contributed to performance. During the third quarter, IA Clarington Emerging Markets Bond Fund was terminated and is no longer held within the Fund. The fund manager gained exposure to emerging markets fixed income through an ETF.

## Recent Developments

Since late March 2020, U.S. equities, as measured by the S&P 500 Index, have nearly doubled in value (the fastest approximate 100% jump in the history of the index) and interest rates remain at historically low levels. The fund manager believes that current stock market valuations will likely leave many investors with the impression that the stock market has become speculative, and that a defensive position is necessary. Others will instead see the positive monthly returns of their portfolios accumulate and seek to take risks beyond their tolerance.

The Fund is neutrally positioned in both equities and bonds, with a slight overweight allocation to Canadian equities, offset by an underweight exposure to U.S. equities, which have become relatively more expensive.

Effective April 30, 2021, the Fund commenced offering Series I units. Effective August 27, 2021, the Fund commenced offering Series LX and X units. Effective

August 27, 2021, the Distinction Balanced Class (the Terminating Fund) merged into the IA Wealth Balanced Portfolio (the Continuing Fund). Pursuant to the merger, the Continuing Fund acquired the investment portfolio and other assets of the Terminating Fund in exchange for shares in the Continuing Fund. The Continuing Fund did not assume the liabilities of the Terminating Fund.

Certain series of the Fund, as applicable, may make distributions which the Manager may change from time to time. If the aggregate amount of distributions in such series exceeds the portion of net income and net realized capital gains allocated to such series, the excess will constitute a return of capital. The Manager does not believe that the return of capital distributions made by such series of the Fund have a meaningful impact on the Fund's ability to implement its investment strategy or to fulfill its investment objective.

## Related Party Transactions

The Portfolio Manager is affiliated with the Manager as they are both under common control of Industrial Alliance Insurance and Financial Services Inc. ("Industrial Alliance").

For the provision of management services, the Manager received management fees from the Fund, based on the average Net Asset Values of the respective series. The management fees paid are disclosed in the financial statements.

The Manager paid the operating expenses of the Fund (the "Operating Expenses") in exchange for the payment by the Fund of a fixed rate administration fee (the "Administration Fee") to the Manager with respect to each series of the Fund, except for Series I and Series V, if applicable.

The Manager pays the operating expenses of the Fund, other than Fund Costs, in exchange for the payment by the Fund of a fixed rate administration fee (the "Administration Fee") to the Manager with respect to each series of the Fund, except for Series I and Series V, if applicable. The expenses charged to the Fund in respect of the Administration Fee are disclosed in the Fund's financial statements. The Administration Fee is equal to a specified percentage of the net asset value of a series, calculated and paid in the same manner as the management fees for the Fund. The Fund's most recent simplified prospectus contains further details about the Administration Fee.

In addition to the Administration Fee, each series of the Fund is responsible for its proportionate share of certain other operating expenses ("Fund Costs"). Further details about Fund Costs can be found in the Fund's most recent simplified prospectus. The Manager, at its sole discretion, may waive or absorb a portion of a series' expenses. These waivers or absorptions may be terminated at any time without notice.

During the 6-month period ended September 30, 2021, the Fund paid \$0 (6-month period ended September 30, 2020 - \$367) in brokerage commissions to IA Private Wealth Inc. (formerly, Industrial Alliance Securities Inc.), a subsidiary of Industrial Alliance.
